## Subject: Urgent Concerns Regarding the Well-Being of Vulnerable Residents

Dear Authorities,

I am writing to bring to your immediate attention **Case No. 3**, as our primary concern is always the well-being of vulnerable individuals.

Today, I wish to highlight the situation of **Mr. Anthony Camilleri**, a resident at **Fundazzjoni Wens**. As previously mentioned two weeks ago, Mr. Camilleri has expressed a desire to run away from his residence and has even voiced thoughts of self-harm.

A concerning yesterday during **Martin's funeral**, where many witnessed Mr. Camilleri arriving in a wheelchair. However, it is widely known that he is fully capable of walking. Additionally, it was observed that he was strapped with a harness to the wheelchair. While we understand that this may have been done as a safety measure to prevent him from running away, the real issue is far greater.

The most pressing concern is **why so many residents feel the need to escape from the facility**. It is highly unlikely that individuals would attempt to flee without a serious reason. Instead of addressing the root causes of this distress, the issue appears to be hidden or ignored. This raises serious red flags.

Previously, Mr. Camilleri was taken to a **health center** following an attempted escape, during which he expressed suicidal thoughts. Following this, he was not sent to work at **Farsons**, where he had been employed. The recent events further confirm the severity of the situation.

I would like to **express my gratitude** to the **SCSA in Santa Venera** for their willingness to understand and hold discussions with us regarding these concerns. However, immediate action is required to **address the fear and distress affecting these residents**.

This matter should not be politicized—**the focus must remain solely on the well-being of these vulnerable individuals**. While many ministers and members of parliament from both sides have shown support, it is disappointing that those directly involved have remained silent.

I urge you to **take immediate steps to investigate and ensure the safety and dignity of these residents**. We have already provided Ms. Ruth, CEO of SCSA, with many emails, same that this emails sent to many authorities showing of our concerns. However, as authorities, you have greater power than **Doninu Malta** to take further action.

While some may dismiss us as insignificant, we remain committed to uncovering the truth and advocating for these vulnerable individuals.

I look forward to your prompt response and action on this urgent matter.

"I believe that if we put vulnerable people first, we can handle this situation successfully. There are many rumors about us, so let me be direct: if someone doesn't want to hear what we have to say, they can simply send us an email, and we'll remove them from our mailing list.( BUT IN WRITING ONLY) For those who are interested, and if no one was interrested we will address the general public."
