Dear ,Ms.Rhoda Garland Commissioner for Disable Persons

I am writing to express my deep concern regarding recent developments surrounding Fundazzjoni Wens and, more urgently, the case of Martin Ambinette, who has been reported missing (Today is the second day). As an organization working closely with Fundazzjoni Wens and its residents, we are alarmed by the handling of this situation and the apparent lack of accountability.

While recent media reports, including those in *The Times of Malta*, have focused on maintenance issues within Fundazzjoni Wens, such as a damaged (Store) ceiling, an unclean armchair, and a roof door in need of repair, these are routine maintenance concerns that should not overshadow more critical matters. To our knowledge, no one from Fundazzjoni Wens has been investigated by the police or taken to court for wrongdoing, which raises concerns about the narrative being presented.

However, the disappearance of Martin Ambinette is an issue of far greater urgency. This is not about infrastructure but about a vulnerable individual's safety and well-being. Martin has a heart condition, relies on a pacemaker, and is currently without the medication he requires daily. His well-being should be the priority.

Given this, we ask: Who is taking responsibility for this situation?

- What actions are being taken by CRPD to address this urgent matter?
- Commissioner Rhoda Garland, as the representative for persons with disabilities, what steps will be taken to ensure accountability and prevent such situations in the future?
- Where are the relevant authorities such as SCSA?

Our concern is that critical issues affecting disabled persons may be overshadowed by other interests. We urge immediate action to ensure Martin's safety and to implement measures preventing similar incidents in the future. This is not about maintenance issues—it is about human lives.

We hope this matter is treated with the urgency it deserves.
