MEMORANDUM OF UNDERSTANDING (MOU)
Between
The My Body Is My Body Foundation (MBIMB) and
Doninu (Malta) International (DMI)

#### 1. Date

This Memorandum of Understanding ("MOU") is made and entered into on this 14th June 2025 by and between the My Body Is My Body Foundation (MBIMB), a registered charity, and Doninu (Malta) International (DMI), a San Gwann Malta -based organisation.

## 2. Purpose

The purpose of this MOU is to establish a collaborative relationship between MBIMB and Doninu (Malta) International (DMI) to promote child safety education and child abuse prevention. Both parties agree to support the delivery of the My Body Is My Body Programme through schools and community-based activities within Malta and any additional locations subject to prior mutual agreement

This MOU provides a framework for cooperation and does not create a contractual or financial relationship. 3. MBIMB Agrees to:

Provide free access to all MBIMB programme resources including songs, videos, animations, activity books, and lesson plans.

Make all MBIMB online courses available to [Abbreviation] and its representatives.

Provide programme resources in any available languages upon request. Offer additional training and live Q&A sessions via Zoom where needed.

Retain copyright and authorship of all MBIMB materials.

Approve all branding usage and media before distribution.

### 4. Doninu (Malta) International (DMI) Agrees to:

Promote and implement the MBIMB programme within schools and community groups.

Obtain necessary permissions from schools or organisations before presenting to children.

Ensure that all facilitators have:

- Completed a criminal background check (or local equivalent)
- Completed MBIMB's safeguarding training course: Introduction to Child Maltreatment and Safeguarding Children
- o Completed Course 1 (Introduction to Child Maltreatment and Safeguarding Children) and Course 2 (How to Teach the My Body Is My Body Programme) of the MBIMB Programme to ensure they have the necessary training Conduct monitoring and evaluation activities using tools provided by MBIMB.

Submit annual updates on programme implementation and feedback. Use MBIMB materials only for non-commercial, educational purposes.

## 5. Safeguarding and Child Protection

Doninu (Malta) International (DMI) shall ensure all individuals working with children under this programme: Hold up-to-date police clearance as per local laws.

Have completed both Course 1 and Course 2 of the MBIMB Programme to ensure comprehensive training. Adhere strictly to MBIMB's principles of inclusivity, child-centredness, and age-appropriate content delivery. Comply with all local child protection legislation.

## 6. Branding, Media & Publicity

All public-facing communications must reflect the values of MBIMB and may only be undertaken with prior approval from MBIMB.

No changes may be made to any MBIMB materials without written consent. Logos and cobranded content will be prepared by MBIMB at no cost.

## 7. Intellectual Property

All MBIMB materials remain the exclusive intellectual property of the My Body Is My Body Foundation. No materials may be copied, altered, rebranded, translated, or used to develop derivative works without prior written permission.

#### 8. Indemnity

Doninu (Malta) International (DMI) shall indemnify and hold MBIMB harmless from all claims or liabilities arising from the misuse or misrepresentation of MBIMB materials, or conduct during programme delivery.

#### 9. Social Media & Representation

Doninu (Malta) International (DMI) is responsible for its own social media use. Any public statements must clarify that opinions expressed are their own and not those of MBIMB. Misuse of MBIMB branding or actions bringing MBIMB into disrepute may result in termination of this MOU.

#### 10. Dispute Resolution

Should a dispute arise, both parties will form a dispute resolution group to reach a solution. If unresolved, neither party is obligated to enter into a binding agreement beyond this MOU.

## 11. Legal Standing

This MOU does not create a legal partnership or financial obligation. Each party may pursue other partnerships independently.

- 12. Both parties acknowledge that this collaboration is entirely non-financial in nature. Doninu (Malta) International (DMI) operates without financial transactions, donations, or commercial activity. No financial exchange, fundraising, or monetary obligations will be undertaken under this agreement.
