



# Statute of Guardians of Grace

*A Section of Doninu (Malta) International*

## Preamble

We, as part of Doninu (Malta) International, establish *Guardians of Grace* as a sacred and humanitarian initiative bringing together people of all religions, called to walk together in the spirit of peace, compassion, and divine love.

This section is entrusted with the mission of interfaith unity, spiritual dialogue, and concrete action in favour of the vulnerable — especially those affected by war, violence, and injustice — in obedience to the command of God to love and serve humanity.

## Article 1 – Name and Structure

1. The name of this section shall be **Guardians of Grace**.
2. It is officially founded and administered as a section of **Doninu (Malta) International**, a non-profit and independent humanitarian organisation.
3. Guardians of Grace shall operate under the legal and moral framework of Doninu (Malta) International and is bound by its founding mission and values.

## Article 2 – Founding and Oversight

1. **Doninu (Malta) International** is the sole founder of Guardians of Grace.
2. This section is led and entrusted to the **Religious Affairs and Interfaith Director**, currently **Archbishop Svetoslav Vasileff**, who also serves as a member of the central Board of Doninu (Malta) International.
3. The **Board of Administration** of Guardians of Grace shall be **the same as that of Doninu (Malta) International**, with the distinction that the **primary spiritual leader and representative of this section is *Archbishop Svetoslav Vasileff***.

## Article 3 – Mission and Purpose

Guardians of Grace is dedicated to:

1. Promoting **peace and reconciliation** through interreligious unity.
2. Acting in **humanitarian solidarity** with victims of war, persecution, and injustice.
3. Fostering **spiritual harmony and understanding** among all faiths.
4. Living out the divine call to **love all people** as brothers and sisters.
5. Bearing witness that **faith leads to action**, and that true worship includes defending the dignity of the vulnerable.

## Article 4 – Values and Principles

Guardians of Grace, as part of Doninu (Malta) International, upholds:

- The **sanctity of life** and dignity of every human person
- **Interfaith respect**, without conversion or coercion
- **Neutrality in political and national conflicts**
- **Service over status**, humility over hierarchy
- **Fidelity to divine truth**, expressed through action

## Article 5 – Activities

- Coordinating **interfaith dialogue and prayer gatherings**
- Sending **peace delegations and missions** to conflict zones
- Providing **relief to refugees and war victims**
- Hosting **educational seminars** on religious cooperation and human dignity
- Advocating publicly for **justice and human rights** in accordance with divine principles

## Article 6 – Membership and Participation

1. Guardians of Grace welcomes members from all faiths and backgrounds who embrace its spirit.
2. Religious leaders, communities, and individual persons of goodwill may request to participate, under the guidance of the Interfaith Director.
3. Any official statement, mission, or action must be approved by the Board of Doninu (Malta) International, or its delegated representatives.

## Article 7 – Leadership

1. The **main spiritual and interfaith leader** of Guardians of Grace is **Archbishop Svetoslav Vasileff**, appointed by the founder organisation.
2. The **Board of Doninu (Malta) International** retains full administrative oversight.

3. Guardians of Grace may create advisory councils or spiritual assemblies with the approval of the main board.

## **Article 8 – Finances and Donations**

1. All financial matters are managed transparently under the financial regulations of Doninu (Malta) International.
2. Guardians of Grace does not seek profit and accepts only ethical donations in line with its values.
3. Funds are used exclusively for spiritual, humanitarian, and peacebuilding purposes.(Not in Malta)

## **Article 9 – Amendments and Dissolution**

1. As a section of Doninu (Malta) International, any amendment to this statute must be approved by the main Board.
2. Guardians of Grace may be dissolved only by decision of the Board of Doninu (Malta) International, and in such a case, its missions and resources shall revert to humanitarian use.

## **Article 10 – International Outreach**

1. Guardians of Grace shall act both locally and internationally, responding to spiritual and humanitarian needs wherever they arise.
2. It may establish partnerships with other religious, interfaith, or humanitarian organisations, subject to approval by Doninu (Malta) International.
3. All collaborations must remain aligned with the organisation's core principles of neutrality, compassion, and respect for all religions.

## **Article 11 – Spiritual Autonomy Within Unity**

1. Each participating faith tradition within Guardians of Grace retains full spiritual autonomy and integrity.

2. No member or representative may attempt to convert, impose, or diminish another's faith within the context of the alliance.
3. Shared prayer events and symbolic gestures shall always be based on mutual respect, transparency, and voluntary participation.

## **Article 12 – Symbols and Representation**

1. The visual identity of Guardians of Grace shall reflect its values of unity, peace, and divine harmony across faiths.
2. Any emblem, name, uniform, or official representation must be approved by the Board of Doninu (Malta) International.
3. Public statements in the name of Guardians of Grace may only be issued by the Interfaith Director, the Board, or a delegated representative.

## **Article 13 – Code of Conduct**

All members and representatives of Guardians of Grace shall:

- Act with dignity, respect, and responsibility
- Avoid all actions or speech that may cause division or offence
- Protect the dignity and safety of those they serve
- Uphold confidentiality and honesty in humanitarian missions
- Commit to resolving internal differences through dialogue and peace

## **Article 14 – Legal Standing**

1. Guardians of Grace does not have a separate legal personality from Doninu (Malta) International, but operates as its officially recognised section for religious and interfaith action.
2. All legal, financial, and official matters are governed by the legal status and statutes of Doninu (Malta) International.
3. This statute, while subordinate to the primary statute of Doninu (Malta) International, shall serve as the guiding charter for the operation of Guardians of Grace.


## Article 15 – Participation of Knights and Other Orders

1. Any **knight belonging to another order**, regardless of their title or origin, may join *Guardians of Grace* **without paying any membership fee**, as long as they sincerely embrace the core values and principles of the organisation.
2. Entire **knightly or religious orders** may also affiliate with *Guardians of Grace* as collective bodies, subject to the approval of the Director of Religious and Interfaith Affairs and the Board of Doninu (Malta) International.
3. This section is open to all **people of good will** who genuinely work for **peace in the world** and uphold **human dignity and compassion**.
4. The organisation is founded on the principle of **spiritual hospitality, unity, and fraternity** beyond borders and religious divides.

## Article 16 – Entry into Force

This statute enters into force on the date of approval by the Board of Doninu (Malta) International and shall remain binding until officially amended or replaced.
