

Nations Alliance for International Mission Founded by Doninu (Malta) International

Article 1: Name and Legal Status

The organisation shall be known as **N.A.I.M.** — **Nations Alliance for International Mission** (hereinafter "N.A.I.M."). It is a non-profit, non-political, international voluntary alliance established under the founding authority of **Doninu (Malta) International**.

Article 2: Purpose and Mission

N.A.I.M. is dedicated to fostering global peace, human dignity, and sustainable development by coordinating and supporting voluntary missions in partnership with the **United Nations** and affiliated bodies.

Its core mission includes:

- Uniting voluntary organisations and faith-based groups under the Doninu umbrella for international mission work.
- Coordinating strategic humanitarian, peacebuilding, and development initiatives globally.
- Advocating for vulnerable populations and promoting universal human rights.
- Strengthening leadership and capacity building among member organisations.

Article 3: Relationship with Doninu (Malta) International

N.A.I.M. is a strategic section of **Doninu (Malta) International** and operates in alignment with its principles, values, and governance.

Doninu (Malta) International is the sole founder and retains full supervisory authority, including the right to amend this statute and appoint or confirm N.A.I.M.'s leadership.

Article 4: Cooperation with V.A.T.E.L.

N.A.I.M. shall work in close collaboration with **V.A.T.E.L.** (Voluntary Administration for Transnational External Leadership), the Foreign Affairs Office of Doninu (Malta) International.

Together, they manage diplomatic relations, international mandates, and external coordination to ensure unified representation and effective operational deployment.

Article 5: Governance Structure

- International Director:
 - The chief executive of N.A.I.M. shall be the **International Director**, appointed by Doninu (Malta) International.
- First International Director:
 The inaugural Director is Eng. Naim Aladgham, (Ambassador for United

Nations) responsible for strategic leadership, international representation, and operational management.

Advisory Council:

A council composed of representatives from member organisations shall advise the Director on mission priorities and strategic planning.

• Secretariat:

The administrative and operational tasks shall be managed by a Secretariat reporting directly to the Director.

Article 6: Membership

Membership is open to:

- Voluntary and faith-based organisations aligned with Doninu's mission.
- Humanitarian actors committed to international human rights and UN principles.
- Individual leaders and experts dedicated to peace and sustainable development.

Membership is non-financial and based on commitment to active participation and adherence to N.A.I.M.'s principles.

Article 7: Functions and Activities

N.A.I.M. shall:

- Coordinate international missions in partnership with UN agencies and Doninu entities.
- Facilitate cooperation and knowledge exchange among member organisations.
- Serve as a liaison for Doninu (Malta) International in multilateral forums.
- Promote and support the implementation of UN Sustainable Development Goals
- Monitor and report on humanitarian and peacebuilding efforts under its mandate.

Article 8: Ethical Principles

All N.A.I.M. activities and members shall adhere to:

- Respect for human rights and dignity.
- Neutrality, impartiality, and non-discrimination.
- Transparency and accountability in all operations.
- Commitment to peaceful resolution of conflicts.

Article 9: Resources and Funding

N.A.I.M. does not engage in commercial fundraising. All resources must be approved through Doninu (Malta) International and adhere to applicable laws and ethical standards.

Article 10: Amendment and Dissolution

- Amendments to this statute may only be made by decision of Doninu (Malta) International.
- In the event of dissolution, all assets and responsibilities shall revert to Doninu (Malta) International for humanitarian use.

Article 11: Representation and External Relations

N.A.I.M. shall represent Doninu (Malta) International and its affiliated entities in all international fora related to peace, humanitarian aid, and sustainable development. The International Director shall have the authority to negotiate and enter into cooperation agreements with United Nations bodies, international organizations, and partner NGOs, subject to approval by Doninu (Malta) International's Board.

Article 12: Reporting and Accountability

The International Director shall provide regular reports on N.A.I.M.'s activities, missions, and partnerships to the Doninu (Malta) International Board. These reports shall include:

- Updates on ongoing missions and collaborations;
- Financial and resource management summaries;
- Challenges encountered and proposed solutions;
- Strategic recommendations for future initiatives.

Article 13: Code of Conduct

All members, staff, and partners of N.A.I.M. shall abide by a strict Code of Conduct reflecting the highest ethical standards, including but not limited to:

- Respect for cultural and religious diversity;
- Zero tolerance for corruption or abuse;
- Protection of vulnerable persons;
- Commitment to transparency and cooperation.

Article 14: Conflict Resolution

In the event of internal disputes or conflicts within N.A.I.M., the matter shall be addressed through mediation facilitated by Doninu (Malta) International. The International Director shall cooperate fully to resolve issues in a manner consistent with the organization's principles.

Article 15: Operational Autonomy

While N.A.I.M. operates under the founding and supervisory authority of Doninu (Malta) International, it shall maintain operational autonomy to swiftly respond to international humanitarian needs and emerging challenges.

Article 16: Effective Date

This statute shall come into force immediately upon ratification by Doninu (Malta) International.

Closing Statement

Through N.A.I.M., Doninu (Malta) International reaffirms its commitment to fostering international cooperation, advancing global peace, and empowering voluntary action aligned with the principles of the United Nations. N.A.I.M. stands as a beacon of hope, unity, and purposeful action in the service of humanity.
